# Bishop's Scholarship Fund

The mission of the Bishop's Scholarship Fund (BSF) is to help families afford Catholic elementary school tuition in the Diocese of Bridgeport. To date, over \$20 million has been awarded to thousands of students attending Diocesan schools in Fairfield County who demonstrate financial need. In 2021-2022, 1,197 students were awarded nearly \$2.5 million.

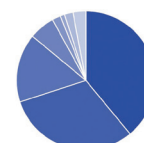

# Innovation and Leadership Grants

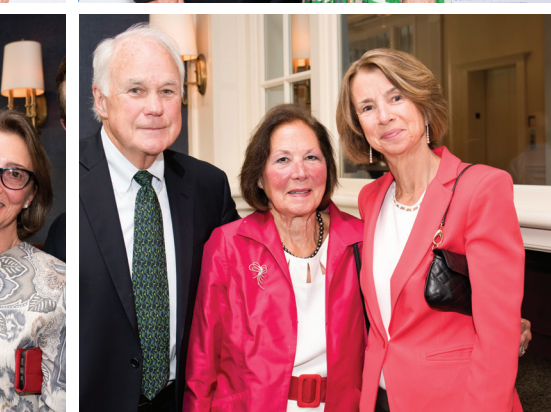
The evening began with children's choir members from Saint Mary School in Ridgefield leading guests with their angelic voices from the cocktail reception to the grand ballroom.

# Transforming the Paradigm of Catholic Education

Through a generous gift from Paula and Tom McInerney, the *Personalized Learning Program* (now in its 4th year) continues to establish a strong foundation in differentiated instruction, blended learning, knowledge of students' needs and abilities, and student ownership across our schools.

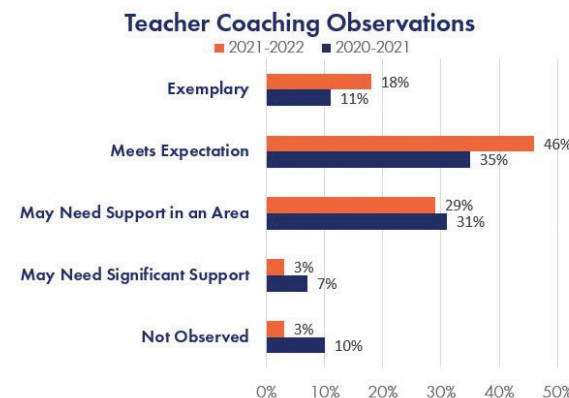


*Personalized Learning* helped our students grow and improve even while pandemic-related challenges continued in the 2021-2022 school year. The strength of our students, teachers, and schools' ability to perform through these challenges has resulted in a 10% increase in enrollment this year - a trend which we expect to sustain going into next year.

and coaching as well as to the loosening of pandemic-related protocols that limited center-rotation in some schools.

Through coaching and observation, leaders are identified as are schools which demonstrate exemplary work in one or more areas of personalization. These leaders become mentors for others within and across school buildings.

*Observation and Coaching* This past year our learning coaches visited 195 classrooms (K-8 English/ Language Arts or Math). Most classrooms were visited several times for observation and teacher coaching. During observations, coaches look for evidence of core personalized instructional practices. Increased adoption of these strategies are evident year-on-year. The success can be attributed to ongoing professional development



# Aquinas Fellowship Program

The *Aquinas Fellowship Community* is a unique opportunity for a recent college graduate to gain valuable experience in a Diocese of Bridgeport Catholic school as an educator, school social worker, or counselor. Fellows earn their Master's degree at Fairfield University and live in a supportive community during their time in the program. The goal for each Fellow is to develop into a highly skilled, motivated, and committed Catholic school faculty or staff member, who will advance Pre-K-12 Catholic education. In addition to an annual stipend, housing and tuition are provided.

For our 2021-2022 school year, three Fellows shared their gifts in our schools and gained valuable experience in exchange.

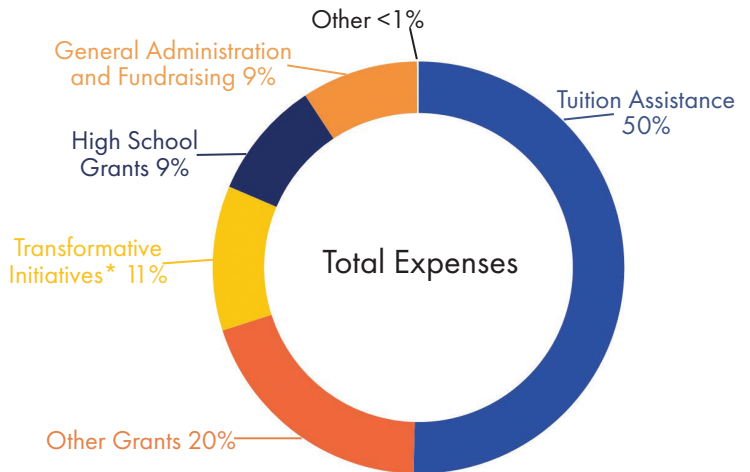
